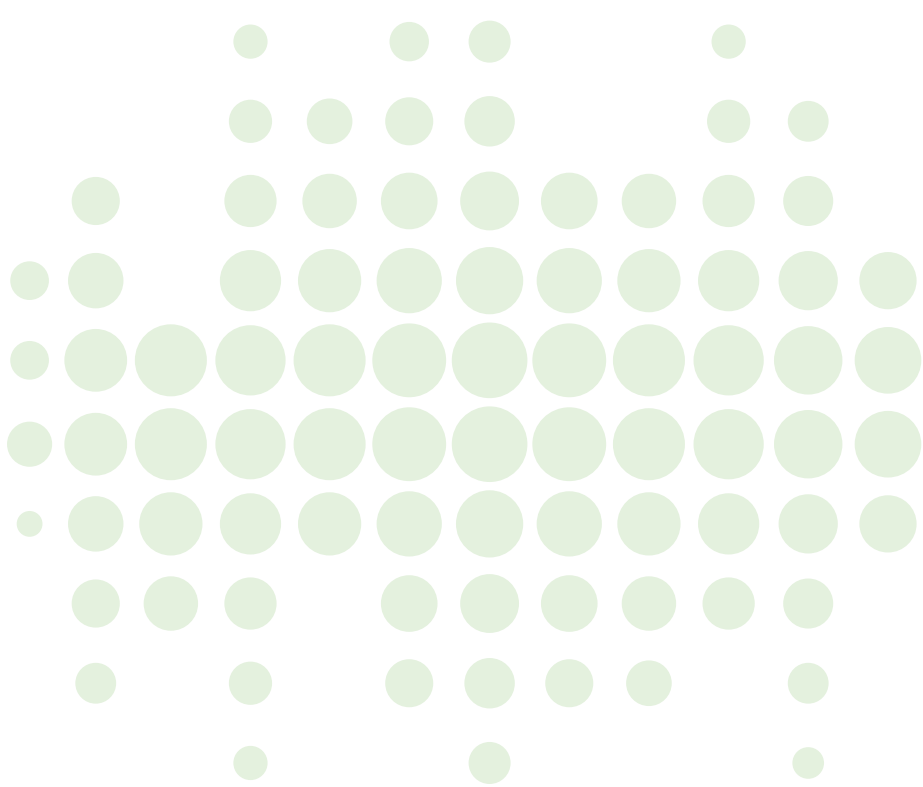

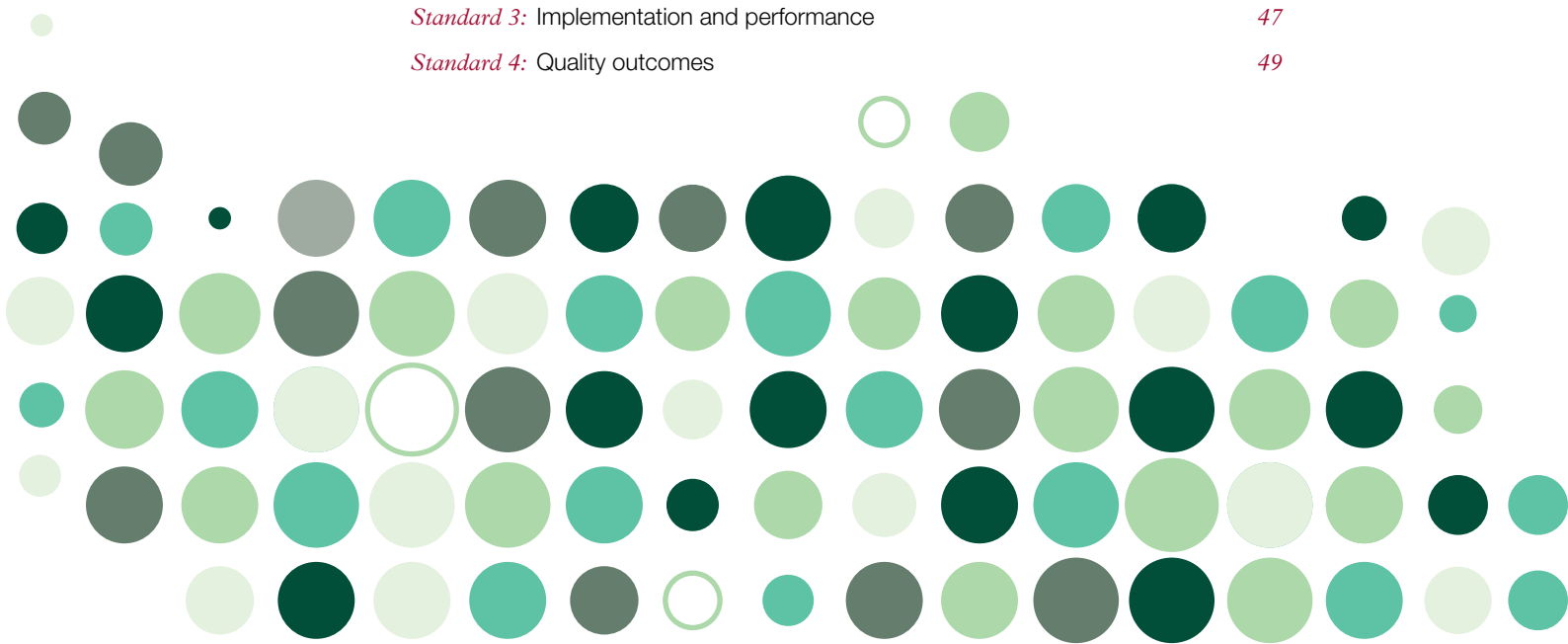

## **Purpose of the *Standards for general practices* (5th edition)**

The Royal Australian College of General Practitioners (RACGP) has developed the fifth edition of the *Standards for general practices* (the Standards) with the purpose of protecting patients from harm by improving the quality and safety of general practices. The Standards also aid general practices in identifying and addressing any gaps in their systems and processes.

The modular format of the Standards allows for the development of additional modules specific to other healthcare settings.

## **Purpose of the *Resource guide***

This *Resource guide* is intended to be read in conjunction with the Standards. It contains useful supplementary information to the Standards to help practices meet the Indicators specified in each module of the 5th edition.
