

# AGPT Training Location Requirements and Commitments

Schedule – September 2023

To ensure workforce distribution, registrars are required to comply with the training location requirements of the relevant program pathway, in addition to training location commitments as set by each region/subregion where applicable. Training Location Requirements

Training location requirements are defined as per the RACGP Training Program Requirements Policy.

## **General Pathway**

Registrars on the general pathway are required to undertake 52 calendar weeks of their Core Vocational Training outside of an inner metropolitan area. This can be met in any of the following ways:

- a rural location classified Modified Monash Model (MMM) 2-7
- an outer metropolitan location
- a non-capital city classified as MMM1
- an Aboriginal and Torres Strait Islander health training post in an Aboriginal Community Controlled Health Service or other approved Aboriginal Medical Service
- two 6-month terms in any combination of the above locations.

## **Rural Pathway**

Registrars on the rural stream must undertake all their training in Modified Monash Model (MMM) 2–7 locations. The rural stream training location requirements do not apply to the mandatory hospital training year.

Extended Skills and Additional Rural Skills Training in MMM 1 locations, where these training opportunities are not available in their training region, may be considered.

# **Rural Generalist Fellowship**

Registrars must undertake at least 52 calendar weeks of their training in accredited training sites in MMM 3-7 locations.

## **Australian Defence Force (ADF)**

Registrars in the ADF are expected to complete all their training location requirements and commitments in the training location they are in. However, if this is not possible due to posting changes, exemptions can be applied for through the national/regional committees as appropriate.

## Regional training location commitments

Regional training location commitments (TLC) are in addition to the training location requirements. Not all training regions have additional TLCs in place. From 2024, the following regions have TLC requirements in addition to the training location requirements.

- Lower Eastern NSW (Central, Eastern and South Western Sydney, South Eastern NSW\*)
- North Eastern NSW (Nepean, Western and Northern Sydney, Hunter Manning and Central Coast\*, New England North West\*, North Coast\*)
- Western NSW and ACT (Murrumbidgee and ACT, Western NSW\*)
- South Australia
- Northern Territory\*
- Western Australia
- South Eastern Queensland
- Victoria

Details related to these requirements are listed in the following pages and may differ from cohort of entry into the program and pathway. Agreement to these requirements formed part of the acceptance into the program and it's an expectation that barring any unforeseen and exceptional circumstances the registrar will undertake these requirements in the stipulated terms.

Whilst exemptions to these requirements are possible, they will only be granted in a small list of circumstances which were not foreseeable at the time of entry into the program. Usually life developments (e.g., marriage, birth of children, spouse employment) will not be considered cause for granting such exemptions.

At present, there are no additional TLCs to the training location requirements for the following regions:

- Tasmania
- North Western Queensland
