Your Role

The Network & Infrastructure Engineer role is responsible for managing and maintaining our enterprise network infrastructure, data centre systems, virtualisation platforms, firewalls, and IT systems. Your expertise in network management, routing, security, systems administration, and cloud technologies will be crucial to ensure smooth operations.

The role is part of the Information Technology Team and is a pivotal role in ensuring service to RACGP staff and members. The role will build strong relationships with all RACGP departments to support all RACGP systems via a well-managed transition to improved member information and build the core platforms to support better member engagement. The RACGP's vision is to make life easy for members and staff.

The overall RACGP technology transformation program requires robust support, governance, management and coordination of activities across the organisation.

Key Responsibilities

- Network Management:
 - Manage enterprise network infrastructure, including Cisco switches, network load balancer and network routing.
 - Ensure optimal performance and security of branch and data centre networks.
 - Administer storage switches for server-SAN connectivity.
 - Manage enterprise Wi-Fi and RADIUS.



- Data centre Management:
 - Administer physical hardware, SAN, and data centre switches.
 - Manage Service Provider connections and layer-2 connection between branches and the data centre.
- VMWare: Manage ESXi hosts, virtual networks, and datastores.
- Palo Alto Firewall:
 - Manage firewall policies, NAT configurations, and IPSec tunnels.
 - Monitor and troubleshoot edge network issues.
- Systems:
 - Administer AD, DNS, DHCP, SMB Share, DFS, AOVPN, NPS, and RDS farm.
 - Manage public DNS and Azure DNS.
 - Manage group policies.
 - Support IIS web servers, Exchange, and Identity Management Systems.
 - Support SOE management with SCCM and Intune.
 - Manage email archiving and email signature with Exclaimer.
- Microsoft SQL (Database):
 - Assist DBAs with backup, recovery, and troubleshooting.
 - Manage SQL AOG for high availability.
 - Administer database access and security.
- Skype for Business 2015:
 - Manage Skype for Business servers, voice gateway, and call centre application.
- Backup, DR & High Availability:
 - Manage Commvault environment, propose HA solutions.
 - Manage Azure backup.
- End-User Device Support: Assist with SOE deployment using SCCM, Intune, Group Policy, and PowerShell.
- Security Systems:
 - Manage SIEM, MS Defender, Cisco Umbrella, web proxy, and patch management.
 - Manage email security gateway (Mimecast).
- Cloud Products: Administer Azure services, provide support for Office 365.
- Vendor Management: Obtain quotes and manage renewals for infrastructure systems.
- Project Collaboration: Work with stakeholders, vendors, and project managers on IT projects.
- System Monitoring: Onboard systems to PRTG and SolarWinds as required.
- Comply with all relevant workplace policies and procedures.
- Other duties as required.

Qualifications and Experience

- · Extensive experience in managing enterprise network infrastructure, including switches, routers, and firewalls.
- Strong working knowledge and understanding of network protocols and routing.
- High level of proficiency in implementing security measures, such as firewall policies and IPSec tunnels.
