

'Check' the details

Dear Editor

The fact that the Professional Services Review has been guilty of quoting selectively from Medicare Benefits Schedule (MBS) item descriptors in a way that is intimidating to GPs has been discussed in the medical press and highlighted by the Australian Medical Association (AMA). How disappointing to see the March edition of **check** (Unit 444, Chronic Disease Management, Appendix 3) perpetuating this practice.

For the record, the full descriptor for MBS Item 36 includes, '...OR a professional attendance of less than 40 minutes duration involving components of a service to which item 44 ...applies' and the clarifying note (A5) states, '...[Level D] items also cover cases which need prolonged discussion... For items 23 to 51

'implementation of a management plan' includes counselling services...[and] advice to patients'.

Dear Editor

Dr Gray is correct in that the descriptor for MBS Item 36 contains more information than what was provided in Appendix 3 of the March 2009 **check** unit.

The MBS item descriptors listed in the appendices were provided as a reference guide only and by no means should be used as a replacement for the complete MBS item descriptors. The descriptors were shortened for editorial purposes.

The full descriptor for Item 36 is, '...Professional attendance involving taking a detailed history, an examination of multiple systems, arranging any necessary investigations and implementing a management plan in relation to one or more problems, and lasting at least 20 minutes, OR a professional attendance of less than 40 minutes duration involving components of a service to which item 44, 47, 48, 50 or 51 applies'.

Practitioners should always refer to the current MBS for complete item descriptors. The complete MBS is available on the Department of Health and Ageing's website at www.health.gov.au/mbsonline.

Medicare Australia values feedback from its readers and appreciates the time taken to provide this.
