- Performance and compliance issues may be escalated to the Regional Accreditation Panel.
- On rare occasions where site and supervisor remediation has not been successful and concerns remain, accreditation will be withdrawn. The RACGP will advise de-accreditation in writing.
- Training sites are able to request reconsideration of accreditation or appeal decisions.
