





# Fellowship endpoints

When you train with the RACGP you can choose to train toward being a GP or a Rural Generalist:

- **GP:** Fellowship of the Royal Australian College of General Practitioners (FRACGP) – 3 years
- **Rural Generalist:** RACGP Rural Generalist Fellowship (FRACGP-RG) – 4 years

## What's a Rural Generalist?

A Rural Generalist is a rural GP who is working to an extended scope of practice with skill sets informed by the needs of the community they serve. Their skills encompass comprehensive general practice and emergency care and required components of other non-GP specialist care in hospital and community settings.

### Meet Rural Generalist, Dr Elyse Marx

Elyse first became aware of Rural Generalists and the important role they play in rural communities as a medical student. She's now a Rural Generalist specialising in anaesthesia in Murray Bridge, South Australia, a small community one hour east of Adelaide.



## Choosing your Fellowship pathway

We offer the flexibility for you to choose or change your Fellowship pathway as your needs or interests change.

Whether you're on the rural or general pathway, you can choose to enrol in the Rural Generalist Fellowship:

- on entry in your application onto the AGPT Program
- during your training as a registrar
- after you have become a GP Fellow.



# About AGPT





# About AGPT

The AGPT Program is Commonwealth-funded, offering 3–4 years of full-time training with flexible part-time and recognition of prior learning options. It's tailored to your interests while giving you the skills and confidence to thrive as a GP.

Your training will span diverse clinical environments, including accredited hospital settings, community general practice and in some cases, community non-general practice placements.

The first year of training is hospital-based. After you've met your hospital year requirements, the order you undertake your training is generally up to you.



## Recognition of prior learning and experience (RPLE)

Applying to reduce your training time is optional. It can be applied to the following terms:

- **FRACGP:** Hospital training year – up to 52 weeks
- **FRACGP-RG:** Hospital training year, additional rural skills training year and core emergency medicine training – up to 104 weeks (total).

RPLE cannot be applied to community general practice or extended skills terms, and no more than 26 weeks in a single discipline will be counted in a 52-week period, except for emergency medicine in some circumstances.

Applications for RPLE are submitted after acceptance into the AGPT Program.

**TIP:** If you're considering applying for RPLE, start collecting your supporting documentation early. You'll need it soon after accepting your offer to assess your readiness for community-based general practice training.

## Fellowship examinations

Once you've completed a minimum of two years of training—including your second general practice term—you may be eligible to begin your Fellowship exams.

These exams are designed to evaluate your readiness for independent practice and ensure high standards of clinical competence.

FRACGP exams are held twice annually and include:

- Applied Knowledge Test (AKT) – written multiple choice
- Key Feature Problem (KFP) – written multiple choice
- Clinical Competency Exam (CCE) – online, undertaken after successful completion of the AKT and KFP.

In addition to the above, FRACGP-RG trainees are required to undertake assessments specific to their chosen additional rural skills training discipline.

## Training flexibility

The AGPT Program offers flexibility to support your personal and professional needs:

- **Part-time training:** Available for those needing flexibility. Minimum requirement is 14.5 hours per week across at least two days.
- **Leave options:** Includes sick leave, carers leave, parental leave, study leave, annual leave, and additional leave as per the [Leave Policy](#).
- **Deferral:** You may defer your training commencement to the second semester of the intake year.

### Priority offer preferencing

The RACGP offers priority offer preferencing to doctors who:

- are Aboriginal or Torres Strait Islander
- are employed by the Australian Defence Force
- are enrolled on a state Rural Generalist Coordination Unit program
- have a rural origin
- have a pre-existing rural connection in their rural area of first preference
- preference one of the following rural priority areas of need - Murrumbidgee NSW, New England/Northwest NSW, Northern Territory, Western NSW

# Training structure

## Hospital training and readiness for community general practice

The first year of the AGPT Program is hospital-based, ensuring you develop the clinical competencies required to safely and confidently transition into a community-based general practice setting.

Hospital training can be done at any accredited hospital in Australia or New Zealand and doesn't need to be in your allocated training region.

### Already have hospital experience?

If you've already met the hospital training requirements listed below, you may be eligible to apply for Recognition of Prior Learning and Experience (RPLE)—potentially reducing your overall training time.

### Still gaining experience?

If you haven't yet met these requirements, that's okay. You don't need to complete them before applying or commencing the program. You can gain this experience during your hospital training year.

### Hospital experience

To begin your first general practice term, you'll need to demonstrate the following:

#### Doctors with AMC PGY2 certification

You'll need:

- AMC PGY2 certification
- satisfactory completion of the paediatric competency.

#### Doctors without AMC PGY2 certification

You'll need:

- satisfactory completion of a minimum of 104 weeks (FTE) of hospital work in an accredited Australian or New Zealand hospital, of which 52 weeks (FTE) must be worked at a level above an intern level (generally this means post-general registration), with evidence of education, assessment and feedback.
  - Experience must be within 10 years of starting your first general practice term.
  - If your clinical terms are more than 5 years old or lack sufficient depth, additional experience may be required.
- satisfactory completion of the paediatric competency.

## Paediatric competency

This requirement must be met within five years prior to commencing your first general practice term. You can demonstrate competency through:

- paediatric rotations involving acute, critical illness, and undifferentiated care
- accredited mixed emergency departments (adult/paediatric)
- a combination of paediatric, mixed emergency, and/or general practice rotations
- completion of the coursework and assessments for the Sydney Child Health Program (2017-2023) or Graduate Certificate or Graduate Diploma in Child Health at the [Sydney Children's Hospital Network](#) in addition to experience in paediatric, mixed emergency and/ or general practice rotation/s.

## Community-based general practice training – 18 months FTE

During this stage of the AGPT Program, you'll work and train in accredited community general practices, building the clinical competencies and professional confidence required for independent general practice.

You'll be supported by experienced general practice supervisors and medical educators through:

- one-on-one teaching
- ongoing supervision
- constructive feedback
- formal assessment.

### Out-of-practice education

To complement your in-practice learning, you'll take part in a comprehensive program of paid out-of-practice education support. These sessions are delivered regularly and prioritise face-to-face learning in both small and large group settings, fostering peer connection, shared learning, and professional growth.

You'll also have access to a wide range of Fellowship exam preparation resources and education, supporting your progression toward Fellowship.

### Choosing your community-based general practice placement

Before each training term, you'll be asked to indicate your training intentions. If you're entering a community-based general practice term, you'll take part in the general practice placement process.

This process is designed to offer flexibility and choice for both registrars and practices. It considers:

- your preferences and personal circumstances
- your training needs and program requirements
- the healthcare needs of the communities you may serve.

Placement availability may change each training term and is dependent on many factors including the training facility's requirements and your peer's preferences.

Your community general practice training will need to be undertaken within the region/subregion allocated at the time of offer and you'll need to meet your region's training location commitments (see pages 35-55).

### Employment terms and conditions

While undertaking general practice training, you'll be employed either directly by the training site or under a government-supported single-employer model.

Your community-based general practice employment contract will comply with the [National Terms and Conditions for the Employment of Registrars \(NTCER\)](#), which outlines minimum standards for pay rates, leave entitlements and other employment conditions.



## Extended skills training – 6 months FTE

The extended skills term offers a valuable opportunity to broaden your expertise. You can choose to:

- further develop your skills in community general practice, or
- pursue a special interest area relevant to general practice in a hospital or non-GP community setting.

### Special interest areas

The range of extended skills options is extensive. Examples include Aboriginal and Torres Strait Islander health, palliative care, sports medicine, sexual health and skin cancer medicine to name a few.

You may also choose to undertake an approved academic post during this term.

### Rural Generalist trainees

If you're working toward the Rural Generalist Fellowship (FRACGP-RG), you have the option to use this term to complete the core emergency medicine component of your training or consolidate your advanced skill.

### Choosing your extended skills post

Once you've joined the AGPT Program, you'll receive a list of available extended skills posts. You'll have the opportunity to discuss your options with your medical educator, who can help you select a post that aligns with your interests and training needs.

### Timing of extended skills training

The timing of your extended skills term depends on the type of post:

Type of post	When it can be undertaken
Hospital-based posts	Can be undertaken at any stage of training after the hospital training year.
Community-based non-general practice posts (e.g. sexual health clinic)	Depending on the post, you may be granted approval after successfully completing at least GPT1, and in some instances, GPT2 or 3.
Community-based general practice-based posts	Can only be undertaken after successful completion of all three community-based general practice training terms (GPT1-3).

## Additional Rural Skills Training (ARST) – 12 months FTE (FRACGP-RG)

Doctors pursuing the Rural Generalist Fellowship (FRACGP-RG) will complete 12 months of Additional Rural Skills Training (ARST). This advanced training can be undertaken any time after the hospital year, depending on your individual training plan.

With over **350 accredited posts available** across a wide range of clinical areas, you'll have the flexibility to tailor your training to your interests and career goals. If a specific skill or location isn't currently available, let us know—we're continually expanding training opportunities.

# Training opportunities

During your training you can broaden your scope, pursue your passions, and make a meaningful impact in diverse communities across Australia.

## Aboriginal and Torres Strait Islander health

We're proud to partner with more than 220 accredited Aboriginal and Torres Strait Islander health training sites across Australia.

Training in an Aboriginal and Torres Strait Islander health training site gives you firsthand experience in community-led healthcare. Supported by cultural awareness and safety training and a dedicated cultural awareness officer, you'll:

- gain deep insight into Aboriginal and Torres Strait Islander health
- deliver care that respects culture and community
- better understand health disparities and help close the gap
- apply your learning and experience to support Aboriginal and Torres Strait Islander patients in both ACCHS and mainstream practice.

Ben moved from Victoria to the Northern Territory to pursue his passion for Aboriginal and Torres Strait Islander health. His desire to empower people to lead healthier lives and prevent illnesses is what drew Ben to general practice. ## Academic and research pathways

If you're passionate about research or teaching, RACGP offers academic posts that combine clinical practice with university-based research and education.

Each year, 23 posts are available, including:

- **Australian Indigenous Doctors' Australia (AIDA) post** – for Aboriginal and Torres Strait Islander registrars
- **Australian Journal of General Practice (AJGP) post** – includes editorial experience
- **PhD post** – supports registrars completing a doctorate

Academic posts offer conference funding, mentorship, and career-building opportunities. You can also apply for registrar medical educator posts or pursue a PhD alongside your training.

## Rural and remote training

Training in rural or remote areas builds your clinical confidence and expands your scope of practice. Whether you're on the rural pathway or choose a rural term on the general pathway, you'll benefit from:

- diverse clinical experiences
- strong community connections
- support from experienced rural educators and local team
- significant financial incentives.

For doctors seeking to train in locations off the beaten track or where on-site supervision is not achievable, we offer several accredited remote supervision training opportunities. These placements are supported by a robust supervision model, with real-time remote access to supervisors, ensuring you're never without guidance.

In addition to clinical support, these opportunities come with substantial financial assistance to help cover relocation, travel, and personal expenses—making rural and remote training both achievable and rewarding.

# Registrar support

During your training, you'll be supported by a dedicated team who'll be your first port of call and provide you with guidance and feedback during training.

## Your RACGP training team

### Medical educator

An experienced GP who will mentor, guide and support you in your education and learning.



### Registrar liaison officer

A registrar peer who can provide confidential advice, information and support.



### Training coordinator

Your first port of call for all training related queries (i.e. requirements for training progression, etc). They work closely with the local medical education team.



### Cultural mentor


A member of the local Aboriginal and Torres Strait Islander community who, together with a cultural educator, supports you to develop cultural competency.



In addition, depending on your training journey, you may also be supported by other RACGP team members including (and not limited to) the rural programs team, academic research team, ADF team amongst others.

## Australian Defence Force (ADF) doctors

We recognise that ADF doctors are mobile and require flexibility in their training. Our regional ADF teams will help you meet the RACGP's requirements for Fellowship and can provide tailored support in many areas, including orientation, mentorship, training planning, transfer management, and recognition of deployments/exercises or courses as training time.



## Aboriginal and Torres Strait Islander doctors

Supported by our Aboriginal and Torres Strait Islander Faculty and dedicated Aboriginal and Torres Strait Islander GP training team, as an Aboriginal and Torres Islander doctor, your tailored journey will include:

- support during the selection process
- priority region and pathway preferencing
- mentors, Aboriginal and Torres Strait Islander registrars and peers
- customised webinars, workshops, guidelines and resources
- participation in the Yagila Wadamba Support Program – a bi-annual two-day workshop focusing on exam performance and other key areas of general practice training
- tailored Fellowship examination support.

## Rural Generalist doctors

In recognition of the extra skills and requirements of Rural Generalist trainees, our rural programs team, including experienced rural and Rural Generalist medical educators, provide expert guidance throughout your training journey.

Our team works closely with you to:

- tailor your training to your interests and community needs
- contextualize your learning through connections with training sites offering emergency medicine and additional rural skills
- maintain skills and networks to help you keep skills current and strengthen professional connections
- meet the Rural Generalist Fellowship requirements with assessment and curriculum guidance and support.

## Financial supports

You can access a range of financial supports during your training.

AGPT registrars may be eligible to access the following:

- **\$30,000 salary incentive** when doctors commence training in a community-based general practice term
- **5 days study leave per training year** to help doctors study and attend exams or professional development
- **Up to 20 weeks parental leave** for primary and secondary care givers.

If you train in a rural MM 2-7 location, you may also be eligible for the following:

- **Between \$1800-\$9260 payment** per six-month community-based general practice term in a MM 2-7 location.
- **Between \$5,000-\$30,000 reimbursement** per six-month community-based general practice term in a RACGP identified area of need which can be used for relocation, rent, childcare/schooling, respite travel, internet connectivity.
- **\$20,000 payment** for 12-months in community-based general practice terms in the Northern Territory
- **\$6,000 reimbursement** for Rural Generalist education courses for FRACGP-RG registrars.
- **Reduction of HELP debt** for rural training
- **Additional incentives** via the Workforce Incentives Payments (WIP) program.


# How to apply





# How to apply

There are five key steps in the application and selection process.



## Step 1: Check your eligibility

To apply for the AGPT Program you'll need to:

- ✓ hold general registration by the commencement of training (the start of the first semester of their intake year).
- ✓ be an Australian or New Zealand permanent resident or citizen or hold a temporary 309, 482, 485, 491, 494 or 820 visa.
- ✓ have at least two exam semesters remaining if you have already sat RACGP Fellowship exams since January 2019.

If any of the following apply, you can still apply, however your eligibility may need further review by the [Training Program Applicant Review Panel](#):

- ✓ you're on a 790 visa or a Bridging Visa A (BVA 010) or Bridging Visa B (BVB 020).
- ✓ you have medical registration conditions or undertakings on your Ahpra medical registration.
- ✓ you're currently enrolled on another training program.
- ✓ you've previously withdrawn or been withdrawn from any specialist medical.



## Step 2: Apply online

After you've checked your eligibility, your next step is to apply online via the [RACGP website](#) during the application period.

In the application, you'll be asked to answer questions and where applicable, provide supporting documentation relating to your:

- contact and personal details
- residency status
- medical registration status
- previous or current medical specialty training
- primary medical qualification
- rural origin, rural connections, Rural Generalist training and other information relating to [priority preferencing](#) as applicable
- training pathway (rural or general) and training region preferences

You're not required to provide referees or details of your employment history (unless requested).

More information about the application will be available closer to applications opening.

## Step 3: Sit the national entry assessment

If your application is deemed eligible, you'll be invited to participate in the selection process.

A non-refundable fee of \$190 is required to book and sit the national entry assessment.

### What's the national entry assessment?

The national entry assessment is an online situational judgment test designed to evaluate your ability to reflect on and respond to interpersonal and professional dilemmas using critical reasoning and social interpretation.

You can complete the test from anywhere in Australia or internationally, provided you have a computer with video and audio capabilities and reliable internet access.

### When can you sit the assessment?

The assessment is held multiple times throughout the year. However, you must book and sit the assessment in time for the application period you are applying for. Please see the [list of assessment dates matched to application periods](#).

#### Important notes

- You can only sit the assessment once per calendar year (1 January – 31 December).
- Your result will apply to any RACGP training program application (FSP or AGPT) made during that year. If your performance is below the minimum standard, you won't be able to make any further applications to any RACGP Fellowship training programs in that calendar year.
- Assessment outcomes are valid only for the calendar year in which you first applied.






# AGPT priority preference framework

AGPT offers will be allocated in the following order.

Residency status	Priority grouping order*
Australian citizens or permanent resident holders and New Zealand citizens	<ol style="list-style-type: none"><li>1. Aboriginal and Torres Strait Islander or Australian Defence Force applicants with either a rural or general pathway first preference (guaranteed place).</li><li>2. Applicants enrolled on a state/territory based Rural Generalist Coordination Unit with either a rural or general pathway first preference.</li><li>3. Applicants whose first preference is a rural pathway and can demonstrate <b>rural origin</b> (defined as residing in an Australian rural MM 2–7 area for at least 10 cumulative years or 5 consecutive years during childhood, including primary and/or secondary schooling).</li><li>4. Applicants who can demonstrate a <b>rural connection</b> to their rural pathway first preference region/subregion:<ul style="list-style-type: none"><li>• <b>Residential:</b> resided in a rural area of their rural pathway region/subregion of their first preference for at least 24 consecutive months - current or past residence.</li><li>• <b>Educational:</b> completed a minimum of 24 consecutive months of rural clinical school or professional placements in a rural area of their rural pathway region/subregion of their first preference (i.e. longitudinal placement, rural clinical school or attended a rural campus).</li><li>• <b>Employment:</b> clinical work experience in a rural area of their rural pathway region/subregion first preference for at least 24 months consecutively.</li></ul></li><li>5. Applicants whose first preference is in an <b>RACGP region of need</b>:<ul style="list-style-type: none"><li>• Murrumbidgee (NSW only)</li><li>• New England/Northwest NSW</li><li>• Northern Territory</li><li>• Western NSW.</li></ul></li><li>6. All other Australian citizens/permanent residents and New Zealand citizens.</li></ol>

## Step 5: Participate in induction activities

To get your training journey started, you'll complete three key induction steps:

1. **Onboarding module** – Submit your CV, hospital term documents, and training intentions (approx. 2–3 hours).
2. **Induction meeting** – Discuss your training plans and next steps with your training team.
3. **Placement confirmation** – Confirm whether you're starting in a hospital or general practice term.  
Note - If you're a doctor on a temporary visa requiring employment sponsorship, your GP term start may be delayed. [Learn more](#).

**TIP:** Start preparing for your onboarding by collecting the required paperwork now.

“One of the things that I find most rewarding from general practice is continuity of care... you see a problem or an issue or a person from the start and you have time to follow that through and look at that in evolution...you don't see them for their disease or their diagnosis, you know about their family and their job and barriers to receiving care. So instead of being systems focused and thinking about the lungs or the heart, I've got the whole person at mind and people really appreciate that.”

# Training pathways





# Training pathways

There are two training pathways available through the RACGP AGPT Program:

- Rural pathway
- General pathway

Training is the same across both pathways—the difference is where you undertake your training.

Choosing to pursue the **Rural Generalist Fellowship** is optional on either pathway.

## Rural pathway

On the rural pathway, you'll undertake your community-based general practice training in rural or remote areas, classified under the Modified Monash Model as MM 2–7. You'll also need to meet any training location commitments for your allocated region.

Doctors affected by the 10-year moratorium can only apply for the rural pathway.

### The 10-year moratorium

The 10-year moratorium applies if you:

- completed your primary medical qualification overseas, or
- were not a permanent resident when you began medical school in Australia.

This means you're only eligible to apply for the rural pathway and cannot apply for the general pathway unless you have a rural pathway exemption.

## General pathway

On the general pathway, you can train in metropolitan, rural, or remote areas. There are two types of general pathway positions:

- composite
- non-composite.

All general pathway trainees are required to complete at least 52 calendar weeks of training outside of an inner metropolitan area and meet any training location commitments for your allocated region.



## Composite pathway positions

If you accept a composite general pathway position, you'll undertake six months full-time equivalent of your community general practice training in a rural area within one of the following regions:

- Murrumbidgee (NSW)
- New England / Northwest NSW
- North Western QLD
- Northern Territory
- Western NSW

The remainder of your general practice training will be completed in your home training region or subregion, unless you choose to undertake additional rural placements. You'll also still need to meet the requirements for all general pathway registrars.

## Region specific training location commitments – all pathways

Depending on your training region, there may be specific training location commitments that you'll need to meet. These training location commitments will apply for the duration of your training.

## Transfers

If you receive a training offer, it's important you only accept it if you can train in the region the offer is for as you'll need to remain in this region for your general practice training. However, we recognise in some situations you may require a transfer. Transfer options depend on your current pathway, training region, and the reason for transfer.
