Outcome 1.2 - As part of improving public genomics knowledge, the RACGP would support the development of a national online databank of living resources (updated as new evidence emerges) for both health professionals and consumers. GPs should be on the panel for the development of any resources, as GPs will often undertake shared decision making with patients regarding genetic testing.
Public genomic knowledge should include harms, risks, costs and limitations associated with genomic testing. It should also include information on identifying scams.

RACGP response:
Direct-to-consumer tests - The RACGP has concerns about commercial, direct-to-consumer tests being offered to consumers without formal counselling, which can have important and lifelong implications for people regarding issues such as life insurance and reproductive decisions.
Therapeutic Goods Administration (TGA) reviews – Each genetic test should be thoroughly reviewed by the TGA to ensure accuracy.
Access to genetic counsellors – The low number of genetic counsellors presents an ongoing challenge. In addition, there is generally low access to genetic counsellors, particularly through the public system, and for people in rural and remote areas of Australia.

Outcome 2.2 - guidelines and educational materials should be government funded. GP-facing guidelines and education should have strong GP input. The RACGP produces two guidelines with genomic information – Genomics in general practice, and Guidelines for preventive activities in general practice (the Red book).

Outcome 2.3 - Detailed genomic testing as a 'fishing exercise' for potential medical conditions represents low value care. De-facto screening programs should be avoided without sufficient assessment of the effectiveness, including health economic analysis.

Data infrastructure should be designed so that genomic testing does not have to be repeated if there are difficulties accessing the original data. Ideally, genomic data should sit securely associated with My Health Record for life-long future access across healthcare system. Some of this detail has been picked up in Sections 1.1.5 and 1.1.6 but should also be explicitly stated here.

Ideally, integrating genomic data into medical software will support better quality improvement and guide appropriate prescribing and clinical decisions.

RACGP response:	

There is a real risk that with geographic and especially financial barriers to access expertise, testing and resulting medication could worsen outcomes, so an understanding of this will be crucial. In addition, an understanding of multimorbidity is essential as it interferes with evidence of effectiveness for personalised medicine or other genomics. Multimorbidity is complex and it will require time, energy, and financial resources to address the challenges this will present for participation.

It should be stated clearly that race is a social, not a genetic construct. Genomics carries the risk, even if unintended, of reinforcing racialised assumptions, such as the notion that "this medicine doesn't work in Aboriginal people" or other culturally defined groups. There is a need for clarity to avoid these misconceptions among both the public and health professionals.
