Description of 2 levels of RACGP approval:

- a) **Endorsement of Clinical guidelines** - Endorsement is only provided for *clinical guidelines* that are produced to National Health and Medical Research Council standard, ie Guideline recommendations are based on the systematic identification and synthesis of the best available scientific evidence.
- b) **Approval as an Accepted Clinical Resource** -Approval as an *Accepted Clinical Resource* is provided when a resource is considered to make a useful contribution to general practice. However, the resource is not considered to have been produced to National Health and Medical Research Council guideline standard.
