

The FARGP practising GP RPL pathway recognises the knowledge, skills and qualifications of experienced rural GPs by offering them the opportunity to submit evidence that demonstrates how they meet the specific criteria of the FARGP. The FARGP RPL process is a formal, yet straightforward, process that is completed on the FARGP Online Learning Platform, *gplearning* via the RPL Evidence Checklist.

The FARGP practising GP RPL pathway enables experienced rural GPs to gain the FARGP qualification via recognition of the relevant experience and skills already acquired.

Full RPL will be granted if sufficient and appropriate evidence is submitted.

The core requirements are that the practising GP applying for RPL is a financial member of the RACGP, holds the Fellowship of the College (FRACGP), has worked in rural general practice, has developed advanced skills in one or more areas and shows evidence of reflective practice. The other requirements are listed in a self-assessment checklist (section 2) below that must be completed as part of this enrolment.

Section 2: Self assessment checklist

This project needs to have taken at least 6 months, including planning and evaluation with a community consultation as part of the process. If not, have you completed an academic qualification that is relevant to rural general practice?		
Have you completed advanced emergency medicine training in the past three years of a standard relevant to practice in a rural community?		

Section 3: Other important information

RACGP Rural will advise you of your application outcome (full RPL, partial RPL or RPL denied). In the case that you are either partly successful or denied, you will be contacted to discuss whether you need to submit further evidence or complete additional relevant activities or courses to fulfil the requirements.

The RPL enrolment fee is non-refundable after seven days or once you have commenced the online application process (whichever occurs first).

Section 4: Mentor details

You will need to nominate a mentor for the FARGP. Your mentor can be any member and Fellow of the RACGP you wish to nominate, who is prepared to review your learning plan and uploaded evidence, as well as provide feedback to the Assessor and Rural Censor. Mentors do not need to have the FARGP nor live or work nearby, as the process is completed online. Their time commitment is two hours in total.
