You can only include experience that:

- Have been undertaken as a part of a training program Australian General Practice Training (AGPT) Program or Remote Vocational Training Scheme (RVTS).
- The training must be at an accredited training site/sites with an accredited supervisor.
- The training time was in comprehensive general practice.
- · Demonstrate satisfactory progression.
- · Have voluntarily withdrawn from the training program.
- Occurred in the last five years (five years from the date of lodging application).

Any experience that does not fit all the above criteria will not be considered for RPLE.

In addition, there is evidence to be submitted as a part of the application. Refer to guide and educational proforma.

As noted above, approval of RPLE is not guaranteed and may be for the entirety of the time claimed, partial time or not approved at all. Time allowed for RPLE will be dependent on assessed evidence of prior learning. Time assessed as 12 weeks or less will not be eligible for RPLE.

If you are not progressing as expected in your training your RPLE outcome may be reviewed. We will communicate this to you.

Your medical educator will be your first point of contact about any questions to RPLE applications and for follow up until outcome letters are distributed.

If you are dissatisfied with the outcome and request an explanation, please refer to the **Dispute**, **Reconsideration and Appeals Policy** for your next steps.

Approved RPLE will reduce program time.

RPLE may affect time requirements relating to eligibility for RACGP exams and Fellowship. Please refer to the *FSP Registrar handbook* for more information on exam and Fellowship eligibility requirements.

We recommend that you review all these factors prior to the submission of an RPLE application.
