Experience requirements

To be eligible, you must have:

- A minimum of five (5) years of (full time equivalent) work as a general practitioner, and/or rural generalist, in Australia over the past 10 years.
- This must include a minimum of 18 months (full-time equivalent) in comprehensive general practice, ie working in an undifferentiated primary care setting.

Letters of support

- Letters of support from the practices you've worked in to demonstrate your experience in the past 10 years.
- Each letter should be on practice letterhead and include the specifics of the work you did.
- For each Australian general practice site included in the application, the following is needed:
 - a separate practice description
 - a letter of support from the practice, noting that a change in the number of hours worked, requires an additional, separate document.

The letter of support must:

- be on practice letterhead, and include:
 - dates worked
 - full time or part time
 - total hours worked each week, eg Monday – Friday 9.00 am – 12.30 pm or 1.30 – 5.00 pm
 - exact nature of the work, including duties performed
 - hours spent in face-to-face and telehealth consultation
 - range of presentations
 - patient demographics
- be dated and signed by the Practice Principal (preferably) or Senior Medical Director, CEO, Director, or Practice Manager.
