*This one-day active learning module will assist GPs in the treatment of drug and alcohol-related conditions. Presented by RACGP NSW&ACT and Western Sydney PHN.*

AOD18 will focus on alcohol, stimulants and opioids. Important substance developments such as the rescheduling of codeine, and the changing clinical guidelines regarding opioids will be specifically addressed. Participants will learn to effectively use the 5As framework to provide patient-centred care in alcohol and other drug consultations.

Developed and facilitated by leading alcohol and other drug experts, this educational event will allow health care professionals to practice skills through observation and role play. It will also connect them with local resources to support their patient's journey and their own practice.

At the conclusion of AOD18, participants will be confident recognising and responding to patients who present with drug and alcohol concerns.

**Learning objectives**

At the conclusion of this workshop GPs will be able to:

- Apply techniques from the 5As to facilitate patient change,
- Recognise the risks associated with alcohol, stimulant and opioid misuse,
- Identify treatment options for patients presenting with substance misuse,
- Refer patients to appropriate support services, and
- Utilise Health Pathways for substance abuse presentations.
