Single Employer Model (SEM) – Frequently asked questions (FAQs) to support our registrars, supervisors and training sites	
Registrars – We recommend that Registrars discuss their training intentions in collaboration with their Medical Educator and Training Coordinator	
Can I complete the RACGP AGPT program if I have opted in for SEM?	Yes. Please ensure you meet the eligibility requirements of your state or territory SEM.
Can I be part of the SEM in a metro area?	We encourage you check that you meet the eligibility and requirements of your state or territory SEM.
If I have opted in for the SEM will this impact my application for the AGPT program?	No. The current RACGP application and selection process remains the same.
Do I have to follow the Rural Generalist (RG) fellowship pathway to be part of SEM?	Eligibility criteria vary between states and territory. Please check the requirements of your state or territory SEM.
If I opt in or opt out of the SEM does this affect my progression to fellowship?	No. Your progression through the RACGP AGPT program is not dependent on whether you are under the SEM.
If I am employed more than 38 hours per week does this reduce my training time with the RACGP AGPT program?	No. Regardless of whether you are employed or under SEM, the RACGP determines 1.0FTE to mean 38 hours per week. This includes all practice time, education, and AGPT program activities – the composition of which will vary depending upon your stage of training. If I have opted in for the SEM, will this affect my Nationally Consistent Payments (NCP) whilst I am in a community GP term?	No. Eligible registrars will continue to receive their Nationally Consistent Payments (NCP) whilst in their community GP terms. Please see Registrar Payments

Can I apply for leave from training if I have opted in for the SEM?	Registrars are entitled to a range of leave types under the AGPT program; however, we recommend you discuss
	your leave requirements with your medical educator and/or local program team Training Coordinator.

If I have opted in for the SEM, will I still participate in the RACGP placement process for community GP?	Yes. All registrars are required to participate in the placement process which occurs every 6 months.

If I have opted in for the SEM, am I still required to complete the training requirements of the AGPT program?	Yes, regardless of employment arrangements RACGP AGPT registrars will be required to meet all RACGP
