Your Team

The RACGP is currently undertaking a complex transition program to establish its new Profession-Led, Community-Based Training (PLT) capability to train medical doctors in General Practice as a key component of the Department of Health's Australian General Practice Training (AGPT) Program. The PLT transition is a fundamental change to the delivery of GP training in Australia, providing an opportunity to improve the quality, safety and accessibility of GP services for all Australians. This transition will build new capabilities from the ground up as well as transfer capabilities from the existing Regional Training Organisations that currently provide AGPT training services. A growing team is in the process of defining, planning and implementing this business transformation program, with a range of inter-related projects in-flight or being established.

Your Role

To support transition activities, we are seeking a senior Medical Educator to utilise their subject matter expertise in developing the Exam Support module of the Education program. This role is for a fixed term contract until March 2023 with the opportunity to move into an ongoing role post transition.

In the development of the Exam Support module, you will be working closely with the Principal Medical Educator, the National Clinical Lead – Assessment, Manager Assessment Innovation, Lead Medical Educator Transition, the Education Program Team, wider-RACGP and RTO subject matter experts as required.

The successful candidate will have an excellent understanding of the AGPT training program and application of the RACGP curriculum and syllabus to program delivery. They will have extensive experience in the development of educational activities, excellent written and verbal communication skills and a demonstrated ability to work collaboratively and meet tight timelines.

Key Responsibilities

Under the auspice of the Education Program and with reference to the RACGP's curriculum and syllabus, core education program, and the RTOs' existing programs as shared:

- Lead, with the support of the Program Lead for the Education Program Development project, the development of an AGPT exam preparation program that can be delivered regionally that avoids duplication and complements the exam preparation courses that the RACGP is required to offer to all exam candidates.
- Work with the Education Program team to ensure that project timelines are met
- Comply with all relevant workplace policies and procedures
- Other duties as required
