### Your Role

The National Manager, Funding and Health System Reform role, leads the Funding and Health System Reform Department within the Policy and Advocacy Business Unit. It overseas three teams including Funding, Reform and Regulation, Quality Primary Care Teams, and Business Sustainability.

The Funding and Health System Reform Department:

- supports the provision of safe, sustainable and high-quality general practice care by advocating across a range of areas relating to general practice funding and the systems supporting the delivery of care
- provides support and advice to RACGP Expert Committee Funding and Health System Reform and other relevant sub-committees/working groups (for example Pharmacy Strategy Working Group, Business Sustainability Working Group etc.)
- responds to government initiatives as they impact on GPs, general practices and patient access to general practice services
- provides policy advice to the RACGP President, Board and Media and Communications teams
- develops resources for GPs and general practice staff
- provides our members and their teams with timely advice regarding developments in policy relating to general practice funding and health system reform impacting general practice.

This role will contribute and work collaboratively with the other departments in the Unit and across the organisation to meet the overall strategies and goals of the RACGP.

The National Manager, Funding and Health System Reform will lead by example in continuously building a workplace culture that is diverse, safe and positive for our people. The role will work closely with Program Manager, Funding, Reform and Regulation and Leads for the Quality Primary Care Team and Business Sustainability Teams.
