You will provide strategic advice on Aboriginal and Torres Strait Islander Health policy and equity issues, bringing this focus to high-quality submissions to national reform opportunities and position statements as they relate to the primary healthcare sector.

Using your broad knowledge and understanding of the area, you will conduct research and provide high level advice on a range of emerging health policy and general practitioner education issues and oversee the governance of the Aboriginal and Torres Strait Islander health faculty Council, Education Committee and their Executive.

## **Key Responsibilities**

- Oversight and governance of the RACGP Aboriginal and Torres Strait Islander Health Council, Education Committee and Faculty executive.
- Coordinating RACGP Aboriginal and Torres Strait Islander Health's policy work including:
  - Analysing government policy and actively monitoring emerging issues relevant to Aboriginal and Torres
     Strait Islander health
  - o Providing strategic policy advice and high-level support to management and Faculty executive
  - o Reviewing, updating, writing, and contributing to new policies, position statements and submissions
  - Working with teams across the RACGP to identify and coordinate input to relevant submissions and position statements including research projects
- Preparing strategic briefings for Faculty manager and executive, internal RACGP stakeholders and Faculty members
- Establishing and maintaining support for national advocacy priorities, including our involvement in the CtG Campaign, support for the Uluru Statement from the Heart and the Raise the Age Campaign.
- Maintaining relationships with external policy networks, including through National Aboriginal Community
  Controlled Health Organisation (NACCHO), Australian Indigenous Doctors Association (AIDA), National
  Association of Aboriginal and Torres Strait Islander Health Workers and Practitioners (NAATSIHWP) and other
  medical colleges.
