Your Team

The Fellowship Pathways Division maintains services, standards and processes to ensure consistent and high quality delivery of training across all RACGP Fellowship pathways. This includes Australian General Practice Training (AGPT) Program, the Remote Vocational Training Scheme (RVTS), the Practice Experience Program (PEP), the General Practice Experience (GPE) Pathway (ending 2022), and Rural Generalism Pathway (once established). It encompasses all trainee journeys toward RACGP Fellowship. The Division has major responsibility for establishing cooperative working relationships with a range of external organisations, such as Regional Training Organisations (RTOs), the Remote Vocational Training Scheme Ltd, Government agencies and recognised representative bodies, including General Practice Supervisors' Association (GPSA), and General Practice Registrars' Association (GPRA).

Your Role

Reporting directly to the General Manager Fellowship Pathways the Principal Medical Education Advisor (PMEA) is responsible for the provision of advice and the delivery of major projects concerned with the transition, development, implementation, maintenance and evaluation of the RACGP's pathways (i.e. the Australian General Practice Training program, the Remote Vocational Training Scheme and the Practice Experience Program). The PMEA works closely with senior staff within Fellowship Pathways, Education Services, across other RACGP divisions and a wide range of external partners and stakeholders as required.

The role focuses upon the development and implementation of the pre-vocational education delivery plan and includes the provision of robust, well-researched and timely policy advice to the General Manager Fellowship Pathways and/or the Chief Executive Officer (CEO) and indirectly to the Board. The role has particular emphasis on rationalising the Fellowship pathways to Specialist Vocational Registration.

Implicit in the role is consideration of how learning and assessment is delivered throughout the professional lifecycle of the general practitioner including pre-general practice, general practice under supervision and general practice post-fellowship. The emphasis being to ensure that progression of knowledge and skills are enabled and recorded within a consistent and longitudinal structure governed by a comprehensive policy framework, quality service delivery, coordinated provider networks, directed resource deployment and purposeful cost structure/budget maintenance. It is expected that the role will interface with all Fellowship Pathways functions and work closely with Education Services.

The role has a direct reporting line to the General Manager Fellowship Pathways.

Key Responsibilities

1. Advise the General Manager Fellowship Pathways on major and complex education projects encompassing the stages of creation, development, delivery and life-cycle evaluation.
2. Provide specialist general practice education and training advice particularly in relation to Australian General Practice Training, the Remote Vocational Training Scheme and the Practice Experience program.
3. Ensure evidence and systems are in place for robust reporting of educational governance and quality assurance measures as required.
4. Support the formulation of long-term strategic plans to improve RACGP education and training offerings.
5. Assess information being presented domestically and internationally on medical education developments and the applicability to the RACGP framework.
6. Contribute towards stakeholder consultations and relationships including representing and presenting the work of Fellowship Pathways at workshops, seminars, conferences and meetings.
7. Work with the PMEA in the Education Services Division to gather and integrate information, facilitating vertical and horizontal linkages across RACGP projects and teams.
8. Assist with policy development, coordination and review.
9. Provide support, advocacy and guidance to Fellowship Pathways managers, including:
 - a. eligibility and selection decisions;
 - b. engagement with the Department of Health and RTOs/RVTS;
 - c. clinical review and/or input to correspondence, processes, website content, enquiries, remediation, assessment, meetings;
 - d. AMC or RTO accreditation;
 - e. academic registrar program support;
 - f. critical Incidents;
 - g. GP education and training program evaluation;

- h. Post-RACGP Vocational Training Education Committee (VTEC) approvals for alternative training models;
 - i. stakeholder enquiries on complex training and/or policy interpretation;
 - j. policy input/review;
 - k. RACGP representative at meetings/conferences when appropriate, such as at Lead Medical Educator Committee.
10. Assist with (medical) staff recruitment and in-service training (all staff) when requested.
 11. Review RACGP reports, papers, guides and resources when requested, providing feedback and advice.
 12. Deliver agreed *Work Plan Goals* – to be developed in conjunction with the General Manager.
 13. Participate in the RACGP Performance Review cycle.
 14. Deliver agreed Work Performance Goals – to be developed in conjunction with the General Manager Fellowship Pathways.
 15. Delegated Authority (Budget \$ or otherwise), as approved by the General Manager Fellowship Pathways.
