# **Your Role**

The senior medical educator for exam support oversees the delivery of the exam support programme at the national level. To develop and review national standardised materials in order to allow delivery of an equitable exam support programme for all trainees across the country. This will comprise of pre-exam support materials for use by regional and local Medical Educators, developing materials for post exam feedback to those trainees who are not successful in their exam and the development and delivery of progress testing using recently used FRACGP items,

You will be working with national medical educators to develop the content, as well as working closely with the National Assessment Advisors for each component of the FRACGP assessments.

You will develop materials and training for Regional and local medical educators to deliver a nationally consistent exam support programme.

# **Key Responsibilities**

- Work with the National Clinical Lead for Assessment to develop and deliver a national model for exam support – whilst the emphasis of this role is pre-exam support, you will also contribute to the exam support program as a whole
- Work with the national based MEs to develop the rolling progress test content, delivered on a quarterly basis, as well as linked materials for delivery of national, regional and local pre-exam support delivery
- Ensure delivery of high-quality educational content within the exam support programme
- Support all assessment quality assurance processes
- Liaise with relevant stakeholders in the development of the exam support programme
- Develop content for the Examination Support Online (ESO) modules relevant to examination preparation
  and working with the relevant NAAs to ensure they remain cotemporary with the FRACGP assessments
- Attend relevant committee meetings and working groups
- Attend scheduled meetings
- Assist in the research and development of RACGP assessments and processes.



- Contribute to the development and delivery of the RACGP assessments including selection and in-house assessments
- Adhere to the delivery timelines stipulated for all Assessment related tasks.
- Participate in the RACGP Performance Review Cycle.
- In consultation with you line manager, deliver agreed Work Performance Goals.
